

## Terms and Conditions of the StorageCraft Buy One Get One Promotion

These Terms and Conditions apply to the StorageCraft Buy One Get One Promotion on select StorageCraft perpetually licensed Software Products (the “**Promotion**”). The Promotion is effective between Feb 15, 2018 and March 31, 2018 (the “**Promotional Period**”). To qualify for the Promotion, the Partner must satisfy the following requirements:

1. A reseller participating in the Promotion must be an authorized StorageCraft reseller participating in the StorageCraft Partner Program at the level of Silver or higher (a “**Partner**”).
2. The following perpetually-licensed StorageCraft Products are eligible for the Promotion (the “**Eligible Products**”):
  - a. ShadowProtect® SPX Server (physical) in quantities of ten (10) or more (Windows or Linux) when sold to a single End User
  - b. ShadowProtect SPX Virtual Server (10pk VMs) in quantities of five (5) or more (Windows or Linux) when sold to a single End User
  - c. ShadowProtect SPX Virtual Server Standard (1 Socket) in quantities of five (5) or more when sold to a single End User

The foregoing volume requirements may not be satisfied through a Partner’s resale of Eligible Products to more than one End User.

3. The Partner must purchase the Eligible Products from an authorized StorageCraft distributor and resell the Eligible Products to an existing or intended End User of the Eligible Products during the Promotional Period (a “**Qualifying Transaction**”). Eligible Products resold by a Partner in a Qualifying Transaction are solely for the End User’s internal use, and may not be resold, redistributed, or otherwise transferred except as permitted in the End User License Agreement (“**EULA**”). (For purposes of this Promotion, an “**End User**” is as defined in the EULA.)
4. TRANSACTION MUST BE APPROVED BY STORAGECRAFT. Partners must call StorageCraft for special pricing.
5. The Promotional Pricing is available on a Partner’s sale of Eligible Products to an End User or potential End User in one or more Qualifying Transactions



- in which the total license count among those Transactions does not exceed the following:
- a. ShadowProtect SPX Server (physical) in quantities of thirty (30) or more (Windows or Linux)
  - b. ShadowProtect SPX Virtual 10pk VMs in quantities of fifteen (15) or more (Windows or Linux)
  - c. ShadowProtect SPX Virtual Socket in quantities of fifteen (15) or more
6. The Partner must establish to StorageCraft's reasonable satisfaction that the End User will use the Eligible Products to replace a product which is competitive to the Eligible Products and which is in use by the End User at the time of its purchase of the Eligible Products. Proof of a qualifying competitive take-away may require documentation establishing a similar license count, a recent competitive product or maintenance renewal notice, an original invoice, a screen shot of the competitive product or license key, and/or other documentation reasonably requested by a StorageCraft representative.
  7. To constitute a Qualifying Transaction, the Partner must receive written deal approval from a StorageCraft sales representative who has confirmed that these Terms and Conditions have been satisfied.
  8. This Promotion is available only in the United States and Canada. Promotional Pricing may not be combined with other discounts or promotional offers, including without limitation deal registration discounts. Maintenance purchases and renewals are expressly excluded from the Promotion. StorageCraft may modify, change or amend the terms and conditions of this Promotion at any time, for any reason, and in its sole and complete discretion, including without limitation withdrawing Promotion benefits and pricing, or excluding a Partner's participation in the Promotion. Partner and distributor pricing and participation may vary. Void where prohibited.
